Words with More Than One Spelling

1. Donut/Doughnut: Donut is an informal variant of doughnut.
2. Disc/Disk: Disc is a variant of disk, though it has valid status in the "phrase compact disc" and references to similar media.
3. Nite/Night: Nite is an informal variant of night.
4. Barbecue/Barbeque: Barbeque is a variant of barbecue influenced by the truncation BBQ.
5. Adviser/Advisor: Adviser is the preferred spelling, though it is inconsistent with the spelling of the adjectival form advisory.
6. Amok/amuck: Amok is the traditional spelling, preferred to amuck.
7. Among/Amongst: The -st extension is, in both American English and British English, widely considered an unnecessary appendage. (The same preference applies for amid/amidst and while/whilst; whilst is, at any rate, rare in American English.)
8. Theater/Theatre: The former spelling is preferred in American English, though the latter from sometimes appears in proper names.
9. Collectable/Collectible: Collectible is the preferred variant.



Problem Words and Phrases



1. a while / awhile: "A while" is a noun phrase; awhile is an adverb.
2. all together / altogether: All together now – "We will refrain from using that two-word phrase to end sentences like this one altogether."
3. biannual / biennial: Biannual means twice a year; biennial means once every two years.
4. bring / take: if it's coming toward you, it's being brought. If it's headed away from you it's being taken.
5. compare to / compare with: "Comparing to" implies similarity alone; "compare with" implies contrast as well.
6. continual / continuous: Continual events are frequently repeated, or intermittent. Continuous events are uninterrupted, or constant.
7. compliment / complement: to compliment is to praise; to complement is to complete.
8. Forgo / forego: To forgo is to go without; to forego is to go before and is generally used only in the forms foregoing and foregone, which are themselves rare).
9. Gibe/ jibe/ jive: To gibe (soft g, as in gym) is to taunt or insult (though jibe is an alternate spelling), to jibe with is to coincide or fit, to jive is to deceive.
10. Libel / slander: Libel is written defamation; slander is the spoken equivalent.

Test Your Knowledge USBC Myths



- Myth: Once adopted all league rules are final.
Busted: League rules can be changed by a majority vote prior to the first scored ball being thrown, even if after the organization meeting. League rules may also be changed after the first ball is thrown but only by written unanimous consent of all of the team captions.
- Myth: You can throw a ball with a pin in the gutter.
Busted: A bowling ball must not come in contact with anything before hitting the pins on the pin deck. If the ball hits a pin in the gutter, otherwise known as dead wood, the delivery counts, but resulting pinfall does not count. A downed pin on the lane is also dead wood. USBC recommends dead wood is removed prior to making a delivery so you do not lose your opportunity to score. Illegal pinfall can also occur when pins ricochet after hitting dead wood and knock down pins.
- Myth: You cannot substitute a bowler during a game.
Busted: A team captain can replace a player during a game. The player cannot return to that game, but can bowl any other game in the series.
- Myth: No foul is committed if the buzzer or light did not go off.
Busted: A foul occurs when a part of the player's body encroaches on or goes beyond the foul line and touches any part of the lane, equipment or building during or after a delivery. If the bowler does not release the ball, no foul is committed. The players clothing and shoes are considered part of the body.
- Myth: Ties in standings can be broken with total pins.
Busted: Ties in the standings cannot be broken with total pins, A roll off must be conducted to break first place ties. Prizes for other ties should be combined and distributed evenly.
- Myth: A playoff and a roll-off are the same thing.
Busted: A roll-off is conducted to break ties. A playoff is used to determine the league champion.
